- 4. Where the continuing airworthiness management organisation subcontracts under its management system the service of an (several) organization(s), this certificate remains valid subject to such organization(s) fulfilling the applicable contractual obligations.
- 5. Subject to compliance with the conditions 1 to 4 above, shall remain valid until 24 September 2021, unless the certificate has previously been surrendered, superseded, suspended or revoked.
