# Further to Notice to Mariners numbers 12 of 2017, 26 of 2017 and 28 of 2017 Re – Chart Correction

The Ports and Yachting Directorate, Transport Malta, notifies mariners and the general public that further to Notice to Mariners Nos. 12 of 2017, 26 of 2017 and 28 of 2017 Re – Chart Correction, the below listed areas are to be considered as "Works in Progress" until further notice.

The works in progress consist of shifting of fish cages, marker buoys and the lifting of sinkers and chains. Hence within the below listed areas there could be unlit fish farm cages or unlit buoys and trailing ropes.
