Information regarding renewal of the Driving Licence

1. Il-Liċenzja tas-Sewqan tiegħek ser tiskadi. Din tiġi mġedda għall-perjodu kif indikat fuq quddiem ta' din il-formula a bażi ta' l-ammont dovut.
2. Din il-formula għandha tintbagħat qabel ma tiskadi l-liċenzja tiegħek. Jekk iġġedded il-liċenzja aktar minn sena wara d-data ta' skadenza, flimkien ma' l-arretrati, tkun mitlub/a tħallas €12.00 ħlas amministrattiv.
3. Imla' fl-ispazju provdut id-dettalji personali tiegħek.
4. Waħħal ritratt riċenti bil-kulur ta' kwalità tajba daqs tal-passaport daqs: (45mm x 35mm) fil-post indikat. Ir-ritratt meħud fi sfond ċar, irid juri l-wieċ kollu mill-faċċata, mingħajr kappell, elmu jew nuċċali tax-xemx. Iffirma b'linka skura fil-kaxxa indikata.
5. Ċertifikat mediku jrid jiġi pprovdut kull ħames (5) snin kif indikat hawn taht.
 - a) Għal minn għandu kategoriji C, CE, C1, C1E, D, DE, D1, D1E, g
 - b) Għal minn għandu kategoriji AM, A1, A2, A, B, B1, BE meta jagħlaq l'eta' ta' 70 sena, u kull 5 snin wara dan.
 - c) Għal minn għandu permess għall-garr ta' passiġġieri jiġifieri xufiera ta' garaxx, minibuses, xarabank, meta jagħlaq l'eta' ta' 50 sena, u kull 5 snin wara dan, meta tiskadi l-liċenzja.
6. Meta tkun sodisfatt li segwejt l-istruzzjonijiet kollha, poġġi din il-formola flimkien ma' l-ammont korrett (ċekk jew money order) fl-envelopp ipprovdut, waħħal il-bolla u impustahomlna. **Tibgħatx flus kontanti bil-posta.**
7. Il-liċenzja tas-sewqan il-ġdida li tikkonsisti f'Liċenzja Photocard u Kontroparti tiġi mpustata lilek wara li tiġġedded.
8. Jekk mintix bi ħsiebek issuq aktar, inti mitlub/a sabieħ tavżana bil-miktub u tibgħat il-liċenzja tas-sewqan flimkien mal-formola tat-tigdid fl-envelopp ipprovdut.
9. Persuna ma tistax ikollha iktar minn liċenzja waħda fl-istess ħin.
10. Avża lid-Direttorat għat-Trasport fuq l-Art jekk ma tirċevix il-liċenzja tas-sewqan fi żmien 3 ġimgħat minn meta tibgħat in-Notifika ta' Tigdid. Talbiet magħmula aktar minn 90 jum mid-data li ħarġet il-liċenzja jiġu aċċettati bi ħlas.
1. Your Driving Licence will soon expire. It will be renewed for the period as indicated overleaf at the amount of payment due.
2. This form has to be submitted before the expiry of your licence. If you renew your licence after one year following the date of expiry, together with arrears, you will be requested to pay a late payment of €12.00.
3. Fill in the personal details in the space provided.
4. Fix a recent good quality coloured passport size photo size: (45mm x 35mm) where indicated. It must be taken against a light background showing the full frontal face, with no hat, helmet or sunglasses. Sign in dark ink in the indicated box.
5. A medical certificate is required every five (5) years as follows;
 - a) for holders of categories C, CE, C1, C1E, D, DE, D1, D1E, g
 - b) for holders of categories AM, A1, A2, A, B, B1, BE when you will reach 70 years of age and every 5 years thereafter.
 - c) for holders of passenger carrying vehicles i.e. garage hire, minibus and/or bus/coach, and you will be 50, and every 5 years thereafter, on the expiry of your licence.
6. When you are satisfied that you have followed all the instructions, put this form together with the correct fee (cheque or money order) in the envelope provided, fix the required postage and mail them to us. **Do not send cash by post.**
7. The new Driving Licence consisting of a Photocard and a Counterpart Licence will be mailed to you upon renewal.
8. If you do not intend to drive anymore, you are requested to inform us in writing and return your driving licence and the renewal form in the envelope provided.
9. A person may not hold more than one driving licence at any time.
10. Please contact the Land Transport Directorate if the new Driving Licence card is not received within 3 weeks of sending the renewal notice. Any claim received later than 90 days from the renewal of the card would incur repayment of the card fee.
